In October, 1966, the readers of "Helvetia" were informed of the appointment of Mr Ernst Merz as Honorary Consular Agent in Auckland. Throughout his many years of residence in New Zealand, Mr Merz has never tired of being of assistance to the Swiss community, first as co-founder and secretary of the then Swiss Benevolent Society, then as honorary correspondent to the official representation in Wellington, and during the last 3½ years as Honorary Consular Agent in Auckland. HEDY'S CORNER:

Lucerne, 10th February 1970 (UPI).—Sixty-two per cent of all Swiss women between the ages of 15 and 54 desire franchise and voting rights. Only 31% are against it and the remaining 7% have not yet voiced an opinion.

This is the result of a representative enquiry of the Lucerne Institute of Commerce (Marktforschungsinstitut) Scope AG, which was published last Tuesday (10th February). Altogether 1039 women and girls were interrogated.

The Commerce Institute is of the opinion that its scientifically-set up questionnaire corresponded exactly with the social structure
