INGER H. DALSGAARD is Assistant Professor of American Studies at the Department of English, University of Aarhus, Denmark. A graduate of the University of Aarhus, where she obtained a Cand. Mag. Degree in English and Religious Studies, she has recently completed a doctoral thesis at King's College, University of London, entitled "The Fabrication of America: Myths of Technology in American Literature and Culture." She has published articles and given scholarly papers on Herman Melville, Thomas Pynchon, Mary Shelley's *Frankenstein* and other topics. Her research interests include technology and culture, Asian-American literature, Romanticism and Modernism.

FRITZ GYSIN is Professor of English and American Literature at the University of Berne, Switzerland. He has written two books, *The Grotesque in American Negro Fiction* (1975) and *Model as Motif in Tristram Shandy* (1983), and has published articles on Sterling Brown, Joseph Conrad, Leon Forrest, Charles Johnson, Nathaniel Hawthorne, Langston Hughes, Nathaniel Mackey, George Schuyler, Jean Toomer, Mark Twain, John Edgar Wideman, and Sherley Anne Williams. He is working on a book about boundaries in African American Fiction.

ELIZABETH KASPAR ALDRICH has taught English and American Studies at Yale University, The Claremont Graduate School, The City University of New York, and most of the Swiss Universities. She has published numerous articles in the area of American literature and culture and is currently at work on a book about American hagiography, the lives of secular saints from William Brewster to Marilyn Monroe. She has, in addition, done extensive editing work with scientists in the fields of molecular biology and particle physics.

DONALD E. PEASE is the Avalon Foundation Chair of the Humanities at Dartmouth College. A Graduate of The University of Chicago, Professor Pease received the Dartmouth Distinguished Teaching Award in 1981. Over the last fifteen years he has delivered close to one hundred lectures at professional conferences and in universities within the United States and abroad. The author or editor of seven books, Pease's *Visionary Compacts: American Renaissance Writing in Cultural Context* received the Mark Ingraham prize for the best book in the humanities in 1987. Pease has also been honored with Guggenheim and NEH Fellowships and has directed two NEH Semi-

nars for College Teachers. He is the General Editor for the book series *New Americanists* at Duke University Press.

HENRI PETTER is Emeritus Professor of English and American Literature at the University of Zurich, Switzerland. With a degree from this university and his doctoral dissertation published (*Enitharmon*, 1957), he took up a position at the Biel/Bienne grammar school, leaving after five years to spend one year in Cambridge, MA. While pursuing the research that produced *The Early American Novel* (1971), he was in charge of the newly-created "Lektorat für Amerikanistik" at the University of Berne. He returned to teach at his alma mater and became a full professor in 1973. He has written essays and articles on Shakespeare, Richardson, Dickens, Dickinson, Faulkner, James, Lawrence, Steinbeck, Golding, Mailer, and Updike, and is still patiently curious about American culture and 18th century fiction.

AGNIESZKA M. SOLTYSIK teaches American Culture Studies at the University of Geneva, Switzerland. Her current research interests include the Gothic, evolutionary psychology, and gender studies. She earned her Ph.D. in English at the University of California, Irvine ("Reading for Genre: The Gothic in Nineteenth-Century American Literature").

BORIS VEJDOVSKY teaches the literatures and cultures of the Americas at the University of Lausanne. He has published articles and given talks on various aspects of American literature and critical theory. He has a book forthcoming entitled *Ideas of Order: Ethics and Topos in American Literature*. His current research bears on the modes of resistance of so-called minority discourses in U.S. literature.
