The annual meeting of the Union Helvetia, London Branch, was held on Tuesday, 9th January. The Chair was taken by the President, Mr. F. H. Rohr. The usual routine business of the annual meeting was first disposed of, including Reports, Resignations, and Election of the Committee.

Acceptance of re-election on the part of the President and Committee was declared to be out of the question, as most of them had held office for two or three years during a most critical time, and were effecting a friendly settlement with the parent society. We regret to announce the death, at the age of 63, of Mr. Caspar Rudolph Naegeli, a citizen of Zurich. Mr. Naegeli had been for the last 17 years with the firm of E. L. Bentley, Telegraph Code Compilers, as chief compiler. During the last six months he suffered from insomnia, and since October last was laid up under the care of two doctors and a specialist. The actual cause of his illness, however, remained undiscovered, and he continued to suffer from acute depression and sleeplessness. A month ago he went to Torquay, but no improvement resulted from the change. On Thursday (Jan. 4th) he returned to London and presented himself at his offices next day in an extremely weak, depressed and restless condition, his mind apparently wandering. Mr. Bentley at once secured a private room in a nursing home, intending to have him X-rayed, thinking he was suffering from kidney trouble. The same evening at 6.50 Mr. Naegeli was seen wandering about aimlessly on the two platforms of Queen's Road Tube Station, where shortly afterwards he threw himself in front of a train which passed over one leg and seriously injured his skull. He was at once taken to St. Mary's Hospital, but never regained consciousness and died the following day (Jan. 6th) at 6.30 a.m. The inquest was held on Wednesday, the 10th inst. by the Paddington Coroner, who examined the evidence for nearly two hours. The resident house surgeon said that the post-mortem examination disclosed stones in the gall, and asserted that this was sufficient to produce the symptoms from which Mr. Naegeli suffered. After reviewing the evidence with great care, the Coroner returned a verdict that Mr. Naegeli took his own life whilst of unsound mind.

The deceased was a very clever and lovable man, and the nature of his work was diametrically opposed to a recovery in his state of health. He had no worries of any kind and leaves an aged sister in Kilchberg (Zurich), to whom he was greatly attached and whom he visited every year during his holidays. Although Mr. Naegeli was little
