CHANGES IN THE SWISS ARMY COMMAND.

The death of Army Cores Commander H. Scheibli, has necessitated various changes in the

Scheibli, has necessitated various changes in the high command of the Swiss army. As successor to colonel Scheibli, the Federal Council has appointed, colonel Guisan, hitherto command of the 1st division, who will take over the command of the 2nd Army-Corps at once. Owing to this appointment, the leadership of the 1st division becomes vacant, and colonel Tissot, at present in command of the 3rd mountain brigade, has been promoted. Colonel Frei, head of the 6th division, has laid down his command of the 6th division which he held for the last of the 6th division, which he held for the last eight years, for reasons of health, and his place will be taken by colonel Lardelli, at present comwill be taken by coloner Lardent, at present com-mander of the 5th division, the latter will be re-placed in the command of the 5th division by colonel Joh. v. Muralt, at present a member of the Instruction corps. This means, that during the last two years everyone of the six divisions has received a new commander.

Gothard Fortress: ,, v. Salis. The newly appointed commander of the 2nd Army-Corps, Colonel Guisan, was born at Avenches and is 58 years old. He started his brilliant military career with the Artillery, and was soon in command of a battery, later on he took over the command of the 24th Infantry battalion, which he led to the frontier in 1914. During the war he became chief of staff to colonel de Loys. After the war he held in turn the com-mandership of the 9th Infantry regiment and the 5th Infantry brigade. His promotion to a division leader took place in 1926, when he succeeded colonel Sarasin, who became an Army-Corps com-mander. He subsequently changed the command of the 2nd with that of the 1st division. Army-Corps commander Guisan is one of the most brilliant military leaders of our army, and with his appointment the 2nd Army-Corps will receive a most capable and efficient leader.

The new division commanders Tissot and v. The new division commanders Tissot and v. Muralt are both belonging to the Instruction Corps. Colonel Tissot was born in 1881 at La Chaux-de-Fonds, he commanded in turn the fol-lowing units of our army : 36th Infantry regiment, 3rd Infantry brigade, chief of staff of the 2nd division, he also held an appointment in the general staff.

general staff. Colonel v. Muralt, was born in 1877 and hails from the canton of Zurich, his former appoint-ments include, the command of the 8th Artillery regiment and the 5th Artillery brigade. During the autumn manoeuvres in 1924 he acted as chief of staff of the 1st Army-Corps, he was also a mem-ber of the general staff.

NEW FEDERAL JUDGE.

The two Chambers have elected Dr. Fritz Studer, at present an Insurance Judge in Lncerne, a member of the Supreme Federal Court, in suc-cession to the late Dr. Brodtbeck. Dr. Studer was formerly a member of Parliament, and be-longs to the socialist party.

NEW SWISS ISSUES.

The Swiss Federal Railways will shortly be issuing a new loan to an amount of Frs. 150,000,000, which will provide partly for the conversion or repayment of existing loans due for redemption and partly for continuing the pro-gramme of new construction foreseen in the present year's budget of the Federal Railways. The terms on which the new loan will be issued are aspected to be similar to those of the two are expected to be similar to those of the two Federal Government loans already issued this year — that is to say, a Three and a Half per Cent. loan at a price of about 97 per cent. or 98 per cent.

The continued cheapness of money and abundance of funds for high-class investment has caused a number of public authorities to avail themselves of the favourable conditions for borrowing. Thus the City of Geneva proposes to issue a Three and Three-Quarter per Cent. loan of Frs. 15,000,000 which will be offered at $95\frac{1}{2}$ per cent., and will be redeemable in 30 years at par.

par. The Canton of Grisons is issuing a loan of Frs. 8,000,000 at par which will be redeemable in 1946, and is required for repaying an advance from the Cantonal Bank raised at the time to provide for certain loans which fell due and were the converted not converted.

GERMAN-SWISS TRADE.

The German-Swiss commercial negotiations which have been proceeding for about a week at Berne are reported to have reached a positive stage.

Germany has consented to various relaxations Germany has consented to various relaxations in her foreign exchange regulations, increasing the sum which a German national will be per-mitted to take when crossing the Swiss frontier from Rm.200 to Rm.500 (from £10 to £25 at par). A limit of £1,000,000 has been fixed by the German Government beyond which it will not permit German nationals to take money across the Swiss frontier frontier.

It is probable that, in return for these con-cessions, Switzerland will consent to purchase German coal, sugar and malt to a value of about £2,500,000.

LOCAL. ZURICH.
