AT THE SWISS ECONOMIC

COUNCIL

The 1964 Swiss National Exhibition, to be held in Lausanne, will be nearly twice the size of its predecessor which took place in Zurich twenty-two years ago, and a maximum of sixteen million visitors is expected. It is estimated that the cost of this tremendous show will be about 90 million francs, but this should be covered without too many difficulties.

The Swiss National Exhibition, which the Swiss Observer will talk about more fully in the months to come, will last from May until October 1964, and will give a remarkably fascinating picture of all aspects of present and future life in our country. It is to be hoped that the 1964 Exhibition will not be held at such an unfortunate date as were the previous ones — in Berne and Zurich — which coincided with the commencement of the world wars in 1914 and 1939.

This information was given by two distinguished visitors to London, Mr. Gabriel Despland, Counseiller aux Etats and Chairman of the Swiss National Exhibition, and Mr. Edmond Henry, Chancellor of the State of Vaud. They were the guests of the Swiss Economic Council at a dinner given at the Dorchester Hotel on Monday, 16th October. His Excellency, the Swiss Ambassador, honoured the gathering with his presence. Mr. Christen presided over the meeting, and Mr. Alfred Renou gave a most lively introduction to our visitors from Lausanne.


