BRIGELS — A SWISS FAMILY HOLIDAY VILLAGE

Situated at an altitude of 4,265 ft. above sea level on a broad sun terrace in the Vorderrhein Valley of Canton Graubünden is the family holiday village of Brigels. It can be reached from Chur by road or by the Rhaetian Railway to Tavanasa and from there by postcoach.

The old part of the village is officially protected as an ancient monument. Since the opening of the ski fields on the Péz Artgas up to an altitude of 7,933, the area has also become attractive for more experienced skiers. Two cross-country trails and a ski-roaming route pass through countryside of great charm.

A novelty this winter is the provision of a natural ice rink. Available for visitors are 135 hotel beds and some 1,200 beds in holiday apartments.
