AGRICULTURE IN A TURBULENT WORLD ECONOMY

SETTING THE STAGE

1. Forces shaping the future: The most important forces: Growing population, use and misuse of natural resources, technical and institutional change, changes in human capital, etc...
2. Growing interdependencies and uncertainties: Are interdependencies and uncertainties growing? What changes come from political, economic, trade and market, technological and other forces?

FACTORS OF CHANGE AND UNCERTAINTY

3. Balancing overproduction and malnutrition: The situation of the rural poor. Regional and village level problems. Alleviations of famines.
4. The pressure on natural resources: Economic growth versus ecological stability: protection of soils, waters, minerals and forests. Erosion and salinity. Energy. Market and non-market problems. Legislation.
5. Changes in human capital, technologies, trade agreements and other institutions: Development of education, research and extension. Role of women. Development and choice of relevant, new techniques. Redistributive effects of technological change. New policies and laws. International comparisons of ideological systems. New economic orders and international agreements.

AGRICULTURAL DEVELOPMENT

6. People in rural societies: Social differentiation in rural areas. Local participation in decision-making. The changing role of women.
7. The food chain markets and trade: Distribution of income and wealth in the food chain. Growing international trade. Multi-national firms, product and financial markets. Interdependence of national and international policies. Stability of world agriculture.
8. The structure of agriculture: Adjustments of farms, regional economies, national agriculture and food chains. Interface farm/non-farm economy. Rural development.

9. Policy and research for the future.
