### **10th EAAE Congress: Exploring diversity in the European Agri-food System**

Place : Zaragoza (Spain)

Date : August 28 - 31, 2002

This Congress will provide an opportunity to listen to researchers presenting papers dealing with any part of the entire agri-food system, from agricultural production through food consumption. And it will also stress their interrelationships.

The Congress will be open to many different topics, such as natural resource exploitation, production management, rural development, environmental impacts, policy analysis, agribusiness strategies, agri-food marketing, trade, new information technologies and consumer concerns, just to mention some of them. It tries to select the best papers from the wide interests of our agricultural economics profession in an open context.

### **77th EAAE Seminar: International agricultural trade: old and new challenges**

Place: Helsinki (Finland)

Date: August 17-18, 2001

Although the Third WTO Ministerial Meeting in Seattle collapsed, negotiations on agriculture began last spring in Geneva as mandated by the Uruguay Round Agreement on Agriculture (URAA). The traditional agricultural trade issues seem much clearer than they did at the start of the last round. The URAA established new rules that radically changed the agro-food trade system. Tariff levels are easier to negotiate than non-tariff barriers, and the defined commitments on export subsidies and domestic support can be subject to further cuts without revisiting the definitions. In addition to this core agenda, there are a number of other issues which have emerged as a result of the experience with the

URAA. The EU strongly emphasises the multifunctional role of agriculture and the European Model of Agriculture, which are based on issues that possess characteristics of non-trade concerns. Non-trade concerns involve e.g. cultural landscape, viability of rural economies, animal welfare, questions of health and food safety along with a number of environmental issues relating to agriculture and biotechnology. Problems arise because for these goods and/or services markets are still poorly developed or do not exist at all.

The main objective of the seminar is to bring together economists and other social scientists working in the area of international agricultural trade in order to discuss the implications for agriculture of expected changes in agricultural trade and to assess the effects of new WTO negotiations on agriculture. One important focus of the seminar will be on the economic aspects and policy issues of non-trade concerns.

Keynote speakers at the seminar are: Dr. Philip Abbott, Purdue University, USA; Dr. David Blandford, Penn State University, USA; Dr. Steve McCorriston, University of Exeter, UK; and Dr. Ian Sheldon, Ohio State University, USA.

### **Registration and participation costs**

The cost for the seminar is Euro 200 (FIM 1,200) for members of the NJF or the EAAE and Euro 240 (FIM 1,500) for non-members. This covers registration fee, refreshments, lunch and dinner as well as a copy of accepted papers. Fees do not include accommodation in Helsinki.

## **74th EAAE Seminar: Livelihoods and Rural Poverty: Technology, Policy and Institutions**

This seminar will provide a timely opportunity for a review of understanding about the livelihoods of the rural poor, and in particular of the interacting effects of technology, policy and institutions on rural peoples' livelihoods and welfare.

The main objective of this seminar is to bring together economists and other scientists working in the field of rural and agricultural development in developing countries in order to discuss new insights into rural poverty, its causes and potential cures, from the perspective of an understanding of rural peoples' livelihoods and of the dynamic effects of changes in technologies, institutions and policies.

The following major topics will be addressed:

- livelihood concepts and approaches (including for example a historical perspective, recent developments, key issues, macroeconomic considerations, etc.);
- technology and innovation (including for example C&IT, GMO, low external input agriculture, etc);
- natural resources and the environment (including for example water and land property rights and conflicts, disaster responses, etc);
- governance and rural organisations (including for example policy implementation issues, social capital, decentralisation, role of the state, etc.);
- public goods and access to markets, institutions;
- farm - off farm and intersectoral interactions (including for example the role of agriculture and the non-farm sector, migration, etc.);

## **19th General Meeting of the European Grassland Federation**

**Place: La Rochelle (France) Date: 27-30 May 2002**

The general theme will be the multi-function of grasslands, from their production of quality feed to their contribution to landscapes. Grasslands are not only regarded as a possible source of large quantities of high quality forages. They must also contribute to the production of high quality animal products. The society also expects them to contribute to environment protection, nature conservation and social and economic activities in rural areas.

Economics aspects will be taken in account especially in one of the 5 Plenary Sessions ('How can market and environmental constraints be reconciled in grassland-based systems ?') and within the 15 Parallel Sessions and 5 Poster Sessions. Main topics should be:

- Public policies to support the positive externalities arising from optimum grasslands management.
- World Trade Organisation and impacts on grasslands-based systems.
- Decision making at the farm scale.

- Sustainability of farming systems.
- Development of economic evaluation methods for multi-function grasslands.
- Life quality constraints: economic and sociological points of view.
