

Actual funding requirements in 2008 were CHF 1 million less than projected. The degree of self-financing is moderate, as basic services and facilities are provided free of charge by law. In addition, the NL receives most of its acquisitions as donations, a substantial asset not appearing in any of the fiscal statistics. Compared to 2007 the additional CHF 0.5 million in expenditure reflects the increased commitment of the NL in expanding the electronic collection and digitising analogue publications.

The priority placed last year upon cataloguing and digitisation, is reflected in the shift of expenditure towards the products ‘Catalogues’ and ‘Access’.

During the first performance mandate period the total number of executed working hours increased approximately 5%. The proportion of hours spent on products and development increased from 64% in 2006 to 68% in the report year. Correspondingly the proportion of hours that were used for support work such as general management tasks, training and further education, information technology (IT) and communication decreased.
