Budget and Expenditures 2011/2012

With operating expenses of CHF 37.1 million, the accounts closed CHF 1.3 million below budget. Delays to projects are the main reason for the underspend. CHF 1.1 million were allocated to the reserves for future project costs. Operating expenses were CHF 0.1 million higher than in the previous year, while operating income was reduced by the same amount. As a result, the funding requirement rose from CHF 36.5 million to CHF 36.7 million.

Expenditure on catalogues rose significantly year-on-year, with a smaller increase for preservation and conservation, and outreach. The extra spending on catalogues is mainly attributable to higher internal charges. The costs of the remaining products fell, with the sharpest decline being in information retrieval. One reason for this is the reduction in headcount in the organisational unit concerned.
