Introduction

The Symposium's theme **«Safety and Quality Assurance of Civil Engineering Structures»** was dealt with in five sessions:

- Introduction
- Project and Decision Making
- Planning and Design
- Construction and Inspection
- Human and Organizational Aspects.

For each session, there was a presentation of papers, as well as a panel discussion, sometimes concurrently, sometimes successively.

The technical programme of the Symposium was completed by poster sessions.

The **Final Report** contains edited discussions as well as the Opening and Closing Speeches. It also includes the technical contributions to the Opening Session as well as 18 poster contributions.

The discussions are based on papers presented at the Symposium, and published earlier in the **Introductory Report** or the **Preliminary Report**. It is therefore important to have the full collection of the three **Introductory, Preliminary, and Final Reports**, thus providing a complete information on the proceedings of the Symposium **«Safety and Quality Assurance of Civil Engineering Structures»**.
