## BANNED!

Since the people's celebration of the third anniversary of the Aug. 6 Tompkins Square Park Uprising, police barricades have been placed around the traditional Friday night speakout gathering point at Avenue A and East 7th Street. Commanding Police Chief Walsh has let us know through lawyers that no demonstrations or gatherings, beyond an arbitrary limit, will be permitted along Avenue A.

### DEFY THE NEW PUBLIC ASSEMBLY BAN!

These police state tactics are the first step towards martial law. This latest attempt to crush dissent exposes the desperation of a government clinging to power through police terror and repression.

Their authority can only be maintained through our compliance. Take a stand for people's power.

**SPEAKOUT!** Tompkins Square Park's closing is the first round in the drive by big capitalists to clear the Lower East Side of low-income people, making many more homeless.

Immediately threatened are evicted Tompkins Square Park homeless people on nearby lots, and Lower East Side Squatters, who create revolutionary alternatives to the "New World Order"!

Genocide plans include forcing homeless people to their deaths, in disease-ridden and violence-prone shelters, as well as camps in remote areas across the country. These camps are already being funded by the Federal Emergency Management Agency (FEMA) under the McKinney Act of 1987! F.E.M.A. would run the government under Martial Law Plans developed by Oliver North!
