Thanks to an entirely new formula which allows costs and charges to be distributed over several successive generations, and also due to the non-profit-making character of the organization, the prices asked are particularly advantageous both as far as the purchase price and the charges are concerned.

The enjoyment for life of the chosen flat and all the communal parts of the Residence is obtained in general by an admission payment made in four instalments, and which varies between Fr. 50 000.– and 100 000.– according to the size of the flat. In case of premature death, within the first eight years after settling, or due to departure for whatever cause, the initial payment is refunded, apart from a reasonable charge for the time the flat was used.

There is no age limit for entry to the Residence. It is also open to people slightly disabled. Serious disability cases are examined individually.

Applications will be considered from anyone who would like to reserve a flat for later and would wish to use it as a secondary residence for the time being or sublet it to a third party.
