Fund-Raising Deadline Extended

## Provisional Results Satisfactory

*Fund raising on an international level is no easy task. That is why, for the time being, the results are considered fairly satisfactory. But the moment of truth is drawing nearer: With the 1.5 million Swiss Francs purchase price for the Place of the Swiss Abroad being due at the end of 1988 the outstanding balance is still considerable.*

The original settlement date for the payment of the purchase price had been set at the end of September. But things did not look too promising at that time. With another full million Swiss Francs to go the Place of the Swiss Abroad Foundation was forced to extend the deadline to the end of December 1988 and to ask the owners to postpone the settlement date accordingly. An inquiry into the accounts of regional fund-raising centres taken in mid-August – that is six months into the drive – yielded surprising results: Many of the smaller expatriate organizations

were heavily committed to the drive whereas the flow of money coming in from the larger ones was relatively moderate. Still, the Commission of the Swiss Abroad is optimistic as to the outcome of the campaign: On the occasion of the Assembly of the Swiss Abroad, which was held at Näfels in September, it was generally held that a successful conclusion of the drive is still within reach. After all, in some countries the fund-drive only got off the ground in August or even September, a fact which is reflected in a marked increase in donations made during those months.

## What to remember

The Place of the Swiss Abroad is the Swiss expatriates' contribution to the 700 Years anniversary

celebration of the Swiss Confederation, scheduled for 1991. A permanent symbol of the unity among Swiss citizens at home and abroad it will at a later date house a small information centre on the history and present situation of Swiss expatriates.

The 5569 square metres area is situated directly opposite the «Rütli», on a peninsula extending into the Bay of Brunnen, which is itself part of Lake Lucerne.

Financial support comes from a foundation consisting of the Organisation of the Swiss Abroad, the Swiss Federal Government, the District and Canton of Schwyz, the Commune of Brunnen and Schwyz Cantonal Bank.

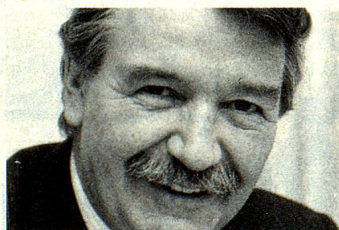

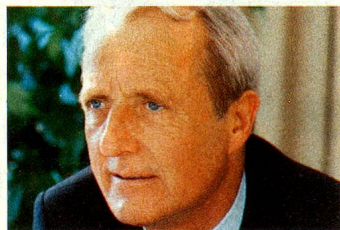

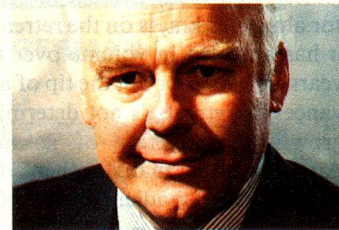
**René Felber, Federal Councillor, Minister of Foreign Affairs:** «The Place of the Swiss Abroad is also a symbol for our foreign policy.»
