The Secretariat for the Swiss Abroad (SSA)

In the service of the Fifth Switzerland

The Organisation for the Swiss Abroad and its head office, the SSA, has been working in the interests of the Fifth Switzerland since 1916. Here is a brief portrait.

The Secretariat is a multi-service centre for assisting the Swiss Abroad. Its first task is to represent their interests here at home, but it also provides services extending from looking after and advising visitors to providing information.

Its legal service provides advice to Swiss citizens moving abroad or returning home – and on many aspects of their sojourn outside Switzerland. The information service publishes Swiss Review,

the information letter for Swiss Associations and promotes media contact within Switzerland. The youth service organises ski and summer camps (see Ping-Pong page) and youth exchange programmes.

Budget cuts resulting from a lower federal subsidy have forced the SSA to reduce some of the services it offers; but its team is busy working out creative solutions to the financial problems and will continue to meet demand in its most important fields of operation.

AJAS (see Ping-Pong page) and the Committee for Swiss Schools Abroad (CSSA) also operate under the aegis of the SSA.
