## Reform of vocational training

Since 1993, the federal government and cantonal authorities have been carrying out a revolution in vocational training. In future, it will be more attractive and more Euro-compatible.

Introducing a vocational diploma is the first step in the reform process. This will follow a federal certificate and will make the holder eligible

to attend a technical university.

It is true that as yet there are no technical universities, but the federal and cantonal administrations are working round the clock to set them up. Courses in engineering, business management and economics should be available by 1996.

More details on this are not yet obtainable, but many Swiss Abroad will certainly be interested. AJAS will represent their interests as the structures for the new universities are being worked out and will give further information in due course.

## Balance sheet in order

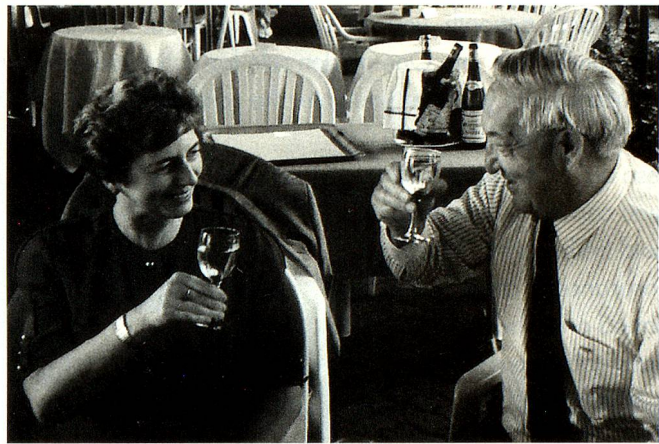
At this year's General Meeting for the Friends of the Organisation for the Swiss Abroad, Chairman Hansueli Ammann presented a neutral balance sheet for fiscal 1993.

The number of members increased by 40 to 321, but contacts with Swiss firms were less successful than those responsible had hoped for.

Members' annual contributions in 1993 came to

about Sfr. 12,000, while capitalised life contributions amounted to Sfr. 10,000. Rosemarie Breitenstein was elected to the committee and became vice chairman.

"Never give up" is the motto of the Friends. Regular mention in Swiss Review and ASS-Info aims at increasing the number of members. More effort will also be made to contact Swiss firms operating abroad.

## Permit requirement for the Swiss Abroad?

Last autumn, the Federal Council presented a draft revision of the Lex Friedrich regulating the purchase of property by residents abroad. The government's long-term aim is to repeal the Lex Friedrich.

But in the interests of harmonising the law with the countries of the European Economic Area, an intermediate step will be to extend the permit regulation to all persons not resident in Switzerland, i.e. also to the Swiss

Abroad. Only people who have been resident in Switzerland for a total of five years will be able to purchase property without a permit.

The Organisation for the Swiss Abroad opposes this extension of the permit system, claiming that it does not accord with the article on the Swiss Abroad in the federal constitution and loosens links between Switzerland and its citizens living abroad.
