# Better access to the Swiss job market

For several years there has been a lack of highly qualified specialists on the Swiss job market. At the same time Swiss university graduates, abroad for additional training, have problems in finding jobs if they wish to return to Switzerland. Job offers are not sufficiently transparent and information reaches job applicants too late. By the definitive emigration of such specialists Switzerland loses many experts who would be gladly taken up by the domestic job market. In the USA and Canada alone there are at present more than 2500 young academicians for whom an attractive environment for the founding of their own company or for an

academic career at a university exists.

Secretary of State Charles Kleiber (Group for Science and Research) intends to create better access to the Swiss job market for young Swiss Abroad with an information platform on the Internet. Together with the Swiss Science Council (SWR) and ATAG Ernst and Young, the GWF has initialised a pilot project by which Swiss job offers for young academicians abroad will be made transparent. The project is linked to a study on the performance indicators and dynamics of the academic job market. For the last five years the GWF, the Federal Office for Education and Science

(BBW) and ATAG have been producing Vision, the Swiss Magazine for Science and Innovation, in German, French and English. The new job market is linked to Vision and may be called up under <http://vision.aey.ch>.

## Initiatives in brief

### Health initiative


The initiative "Health must remain payable" (Health initiative) was launched by the Social Democratic Party of Switzerland. It aims to insert the following new provision in the federal Constitution:

- All insured persons shall have access to a high quality reasonably priced health care geared to needs. Basic insurance should be so designed that no one needs to make additional payments for his health. Health insurers in the field of mandatory basic insurance shall not aim at making profits.
- The initiative does not aim at increasing the market but

at attributing more directing competence to the federal government and cantonal authorities. It should be possible to limit the amount and price of benefits provided in the field of health care.

- Contributions should be structured in relation to the financial possibilities of insured persons. To the extent of one half health insurance shall be financed by premiums dependent on income and property, and to the remaining 50% by an additional value added tax percentage.


