Founded in the 50s by Swiss Abroad, Soliswiss now boasts 8000 members world-wide who benefit from its wide range of offerings. At the Bernese head office of the society, eight staff are employed in the service of members and interested parties.

Since 1996 economist and political scientist Elisabeth Nassar-Ory has been director of the solidarity fund and responsible for strategic development. Under her management the society was renamed "Soliswiss – the Solidarity Fund for Swiss Abroad", its image modernised and its range of products extended. Elisabeth Nassar-Ory is supported by a team of seven employees. The tasks of the Soliswiss team include the provision of information to members and interested parties, individual consulting, processing applications for membership, efficient contract processing, individual account administration, claims assessment, and co-operation with the society's contractual partners Winterthur, KPT and IHI/Visana.

Having lived for seven years in the Middle East, Elisabeth Nassar-Ory knows the needs and problems of Swiss Abroad at first hand. Since not every country is able to offer suitable insurance arrangements, Soliswiss has extended its range of offerings with four insurance plans – Soliswiss PENSION, Soliswiss EDUCATION, Soliswiss FUTURE und Soliswiss FAMILY – that address individual members' needs.

therefore supports individual persons or families who are in need due to no fault of their own, by dint of war, internal unrest or general political reprisals. All services offered by Soliswiss fulfil the requirement of security. The Swiss government, for example, guarantees indemnity for protection against loss of livelihood.
