Revision of the optional AHV

## Swiss Abroad call for amendments

**The Organisation for the Swiss Abroad (OSA) is not satisfied with the Federal Council's proposals for the reform of the optional old age and survivors' insurance and disability insurance (AHV/IV). Amendments are called for, in order that Swiss nationals can continue to enjoy international freedom of movement without losing their social insurance coverage.**

**T**he OSA supports a reform of the optional AHV/IV in principle. However, the draft legislation recently approved by the Federal Council does not adequately address the needs of the mobile members of the Swiss population. In the view of the OSA the Federal Council's bill does not take sufficient account of the results of the public hearing process; too little notice has been taken of the objections and suggestions for improvement lodged by cantons, parties and other interested institutions.

Furthermore, the OSA decries the lack of statistical evidence. The alleged deficit of the optional insurance scheme is not proven; instead of the promised savings, the reform proposal as it now stands would bring substantial extra costs in its wake, emphasises the advocate of the interests of the Fifth Switzerland.

### Social benefits abroad too

The OSA is committed to promoting the continued entitlement of Swiss nationals resident abroad to sufficient social benefits. Despite social security agreements, by no means all Swiss Abroad have the possibility to make adequate provision for themselves in their host countries. In particular, Swiss Abroad not in gainful employment often have no alternative to insurance coverage in Switzerland. This is why more

than 50,000 of our compatriots abroad currently contribute to the optional AHV/IV scheme. In the OSA's view,

this insurance option will continue to be essential in the future in order to secure the unrestricted international mobility of Swiss.

### Corrections to the revision bill

The OSA is therefore calling for an amendment of the revision bill on two counts. Firstly, Swiss Abroad should be able to continue contribut-

ing to the optional AHV/IV scheme, irrespective of the existence of a social security agreement, if their host country offers insufficient provision. Secondly, membership of the optional AHV/IV scheme should not be dependent on coverage for five consecutive years immediately prior to the new law; instead, the criterion should be the effective insurance requirement. ■
