In the area of long-term financial security, cooperation with some of the best Swiss insurance companies has allowed Soliswiss to offer

## New Visual Identity

From the Spring of 2001, a new Soliswiss brochure will be avail-

At the same time, in trying to achieve this objective, the Soliswiss site will become considerably enhanced and attractive. Online advice on insurance products will also be available. Useful links and a broad range of updated information about Swiss political life will be offered.
