## Important information for pensioners in the EU

At the end of July 2002, persons drawing a Swiss AHV-IV pension and resident in an EU member state will receive a letter from the Swiss Insurance Law (KVG) Joint Facility, stating the most important aspects of the impact which the agreement on free movement of people will have on obligatory health insurance. The addresses of pensioners were provided by the Central Compensation Office (Zentrale Ausgleichsstelle, ZAS). The letter provides information on whether or not pensioners are obliged to take out a Swiss health insurance policy for themselves and family members who are not employed. It also lists criteria governing exemption and an information sheet on reduced premiums for pensioners and family members not in employment who are living in reduced economic circumstances and insured in Switzerland. Forms to apply for a Swiss health insurance policy or have your insurance obligations checked, etc., are also enclosed.
