Change in Soliswiss Direction

At the Congress of the Swiss Abroad, held at the end of August, the General Assembly of Soliswiss learned with great regret of the resignation of Mrs Elisabeth Nassar from her position as Director of Soliswiss, as of the end of the year 2004. After eight years of activities for our cooperative, Mrs Nassar wishes to explore new challenges. Our recognition of her contribution will be shown in an appropriate manner at the end of the year.

The Soliswiss Council elected Dr Felix Bossert, on August 19th, as the new Director of the Solidarity Fund for Swiss Nationals Abroad. He will begin his duties towards the end of the year after a period of detailed introduction during the coming months.

Dr Felix Bossert is 47 years old. He has worked for about twenty years in the areas of insurance and financial services for a Swiss company, Swiss Re, through which he gained solid experience in management, especially abroad. He has previous experience in South America and Africa, and was lately

in charge of Japanese and Korean affairs for Swiss Re.

Dr Bossert has been an elected member of the Soliswiss Council for a year. While serving on the Executive Committee, he dedicated himself during the past months, to examining and developing a Soliswiss strategy. This led him to candidate for the position of Director and he was elected by the Soliswiss Council.

In the present context of the growing importance of private insurance worldwide, the Council is convinced that Soliswiss is in a position to develop its line of services further and make it available to a larger number of Swiss nationals abroad. Elisabeth Nassar has created excellent bases on which to develop further. We would like to express our appreciation of her contribution and also take this opportunity to wish Felix Bossert success in his endeavor to achieve our objectives.
