Soliswiss General Meeting

Unreserved approval of the new articles of incorporation

A presentation of new products and services met with keen interest and active participation at the Soliswiss general meeting. The new articles of incorporation were approved unanimously.

Access to vital information in a few clicks: in an exciting presentation at the congress for Swiss citizens abroad held in Interlaken, Soliswiss presented the draft version of its new Internet site. Distinctive features include fresh colours, simple pictorial language and rational design. The clear structure makes it easy to find information intuitively. The forms provide a useful service: in future, users will be able to download, complete and return them via the Internet.

Public and confidential sections

The new Website is divided into public and private sections: www.soliswiss.ch is open to the general public, while www.mysoliswiss.ch is reserved for members for confidential data exchange purposes.

Fast and up-to-date

Why does Soliswiss set such great store by the Internet? Topicality and completeness are strong arguments in favour of the creation and extension of the new Internet site. Swiss citizens abroad can keep fully in the picture about Soliswiss offers wherever they may be, at any time and rapidly; they can also correspond with Soliswiss in encrypted form. The exchange of information via the Internet saves a great deal of time and high postage costs for all users. Members who do not use the Internet can still correspond by ordinary mail. In the words of Ulrich Pfister, the Chairman, "The future lies with the Internet. All changes are being made for the benefit of our own members." Swiss Ambassador Peter Sutter, who was present in the audience,

supported the Chairman in no uncertain terms: "We must make Soliswiss fit to meet the challenges of the future."

Articles of incorporation to the Federal Council

The General Meeting adopted the articles of incorporation in the 2005 version with no opposing votes.

Where do we go from here? The Swiss Foreign Ministry EDA will now lay the articles of incorporation before the Federal Council for approval. Only then can these articles of incorporation and the new business model take effect and the whole new Internet site go online.

Apart from the revision of the articles of incorporation, the General Meeting also approved the annual report, the balance sheet and income statement for 2004; it granted a release to the management committee and executive and elected new members to serve on the executive.

New premises, personal service

After nearly four decades, Soliswiss has moved from the attic level to the newly refurbished ground floor. Customers are welcome to visit us at Gutenbergstrasse 6 in Bern. The range of asset formation, health and life insurance services on offer is changing rapidly. A personal discussion is often the only way of calling attention to the attractive solutions which are available.
