


Die Schweiz entsendet wieder einen Botschafter nach Harare

Die Vorsteherin des EDA hat beschlossen, die Direktion der Botschaft in Harare, wie vor dem Jahr 2001, einem Botschafter anzuvertrauen. Deshalb hat der Bundesrat beschlossen, Marcel STUTZ, bis vor kurzem Minister und erster Mitarbeiter des Missionschefs in Madrid, zum ausserordentlichen und bevollmächtigten Botschafter der Schweiz in den Republiken Zimbabwe, Angola, Malawi und Sambia, mit Sitz in Harare, zu ernennen. Botschafter Stutz hat sein Amt am 5. Januar 2005 angetreten.

Marcel Stutz wurde 1954 in Uzwil/SG geboren und ist heimatberechtigt in Wängi/TG und Degersheim/SG. Er besitzt ein "Master of Arts" der Universität Reading (GB). 1982 trat er in den Dienst des Eidgenössischen Departements für auswärtige Angelegenheiten und wurde als Stagiaire in Bern und Tunis eingesetzt. An die Zentrale zurückgekehrt, wurde er 1984 als diplomatischer Mitarbeiter dem Europaratsdienst bei der Politischen Abteilung I zugewiesen. 1985 wurde er als dritter Botschaftssekretär der ständigen Vertretung der Schweiz beim


Europarat temporär nach Strassburg versetzt und 1986 in der gleichen Eigenschaft nach Lagos, wo er später zum zweiten Botschaftssekretär ernannt wurde. 1989 erfolgte seine Versetzung als erster Botschaftssekretär zu unserer Vertretung in Berlin/DDR, ab 1991 als Konsul in der Außenstelle Berlin und 1992 nach Jakarta, wo er 1994 zum Botschaftsrat ernannt wurde. Zurück in Bern im Jahr 1995, wurde er diplomatischer Sektionschef bei der Politischen Abteilung II, ab 1998 mit dem Ministertitel. Seit 2001 war er Minister und erster Mitarbeiter des Missionschefs in Madrid.
