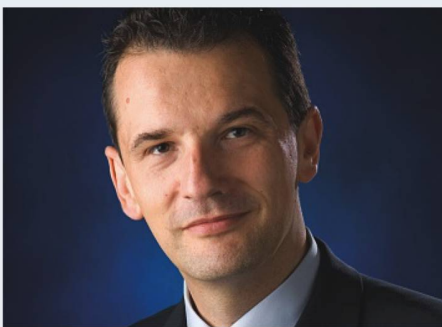

### Elections of CSA delegates in Australia, cont.

In the past, delegates to the Council of the Swiss Abroad were elected by the registered Swiss associations in Australia. This time, however, Australia is taking part in an e-voting pilot program which gives all eligible Swiss in Australia, i.e. those who are over 18 years of age and have registered their email with the Consulate General in Sydney, the opportunity to elect their representatives. If you have not yet provided the Consulate with your personal email address, you must do so by the end of May via the online desk on [www.eda.admin.ch/](http://www.eda.admin.ch/) or by contacting the consulate on [syd.vertretung@eda.admin.ch](mailto:syd.vertretung@eda.admin.ch)

**Participation in this e-voting pilot program is a unique opportunity to make your voice heard, don't miss out!**

The election will be carried out entirely by electronic means. Voting codes will be emailed by 12 June and voters will have until 27 June to cast their vote. Results will be announced by the end of June. Information about the election, candidates and results can be found on the OSA

# Australian Taxation of Swiss Pension Income (AHV/AVS or IV/AI)

How to claim a tax deduction from the Australian Taxation Office (ATO) on a pension paid by the Swiss Social Insurance

If you are receiving an income from the Swiss Social Insurance (AHV/AVS or IV/AI) you may be entitled to claim a deduction, to reduce the amount of tax you pay. The deduction only applies if your pension has an 'Undeducted Purchase Price' (UPP). The UPP is the amount you contributed towards your Swiss Social Insurance in Switzerland – your personal contributions. The UPP does not include the contributions made by any employers.

Australia has made agreements with various countries (e.g. Germany, Italy and Austria) to determine the deductible amount. Discussions aimed at achieving a similar agreement between Australia and Switzerland are ongoing. As a temporary solution, however, beneficiaries of a Swiss pension (AHV/AVS or IV/AI) can individually claim a deduction. For this purpose, you have to complete a 'Request for a determination of the deductible amount of UPP of a foreign pension or annuity', which can be downloaded from the ATO website: <http://tinyurl.com/ksto99o>

To allow the ATO to determine your eligibility, you will need to request a statement from the Swiss Compensation Office in Geneva (Switzerland), certifying the total amount of your personal contribution paid into the Swiss Social Insurance. The

necessary application form can be downloaded from the website of the Consulate General of Switzerland in Sydney:

The completed form should be sent by post or email directly to Geneva.

The Consulate General of Switzerland and the Swiss Compensation Office in Geneva can only advise on the process of obtaining your personal contribution figure. Any questions relating to claiming UPP deductions and taxation must be addressed to the ATO.

## Embassy: Introducing the new Swiss Ambassador-Team for Oceania!

As a novelty in Oceania, the Federal Council has appointed a job-sharing couple to represent the Swiss Government in the Australia-Pacific region. While the two Ambassadors share the responsibility of the Head of Mission at the Embassy of Switzerland in Canberra, they clearly separate their respective accreditations and look after the Swiss relations with a range of different countries in our region: Pedro Zwahlen is the new Ambassador of Switzerland to Australia, whereas Yasmine Chatila Zwahlen has been appointed Ambassador of Switzerland to Kiribati, Nauru, Papua New Guinea, Solomon Islands and Vanuatu.

■ **Pedro Zwahlen** has a Degree in History, Islamic Studies and Constitutional Law from the University of Berne. After two years in the Swiss Ministry of Defense, Mr Zwahlen began his diplomatic career in 1998, first at the Directorate of Political Affairs in Berne, followed by the Swiss Embassy in Rome. From 2000 to 2001, he worked in the Arms Control Section of the Federal Department of Foreign Affairs and at the Geneva Centre for Security Policy. In 2001, Mr Zwahlen was transferred to the Swiss Embassy in Damascus as Deputy Head of Mission. In the same capacity, he was transferred to the Embassy in Lisbon in 2005. Back at Headquarters in 2008, Mr Zwahlen became the Head of the International Security Section and, in 2010, he was promoted Deputy Director of the Division for Security Policy and Crisis Management.



■ **Yasmine Chatila Zwahlen** has a Degree in Islamic Studies, Languages of Northern Africa and Western Asia, as well as English Literature from the University of Berne. She commenced her diplomatic career in 1994, first at the Swiss Development Cooperation in Berne, followed by the Swiss Embassy in Cairo. From 1995 to 1997, she was responsible for the Middle East Desk of the Political Planning Staff of the Federal Department of Foreign Affairs. Between 1997 and 2001, she acted as Foreign Affairs Spokeswoman. In that capacity, she initiated a Swiss Government Information Service in Geneva, catering for international media accredited both to the United Nations Office and the Swiss Government. In 2001, Ms Chatila was transferred to the Swiss Embassy in Damascus as Deputy Head of Mission, and, in 2005, to the Swiss Embassy in Lisbon, again as Deputy Head of Mission. Back at Headquarters in 2008, Ms Chatila took over the responsibility for the Science Diplomacy Section.

In July 2012, the Swiss Government appointed Yasmine Chatila Ambassador of Switzerland to Costa Rica. At the same time, her husband Pedro Zwahlen was appointed Ambassador of Switzerland to El Salvador, Nicaragua and Panama. Both appointments were based at the Embassy in San José de Costa Rica.

On 1 September 2016, Mr Zwahlen took up his new assignment as Ambassador of Switzerland to Australia. In January 2017, Yasmine Chatila arrived in Canberra to take up her duties as Ambassador to Kiribati, Nauru, Papua New Guinea, Solomon Islands and Vanuatu. They have two teenage children who are studying in Canberra.

Yasmine Chatila and Pedro Zwahlen are both looking forward to meeting and working with the Swiss communities in this region!
