6. MAIL

From January 1 to December 31, 1953, the mail registered at the ICRC headquarters in Geneva amounted to 394,212 letters, postcards, telegrams and enquiry cards for missing persons. The incoming and outgoing figures were as follows :

1. GENERAL INCOME AND EXPENDITURE ACCOUNT

It will be ascertained from a brief survey of the following Tables that—

expenditure for 1953 amounted

in consequence the deficit amounted to	<u>Sw. Fr. 1,603,840.82</u>

However, the General Income and Expenditure Account for 1953, concerning previous budgetary years, shows a credit balance of Sw. Fr. 382,472.42.

The balance has been transferred to the Reserves and Provisions Account, of which a Summary is given in Table IV.

The ICRC sincerely hopes that generous contributions from Governments and National Red Cross Societies will enable it to reach, in 1954, the financial equilibrium required for its working funds and budget, for which active steps are being taken to reduce expenditure.

2. GENERAL ACCOUNT FOR RELIEF WORK

At the end of December 1952, the balance of the General Account for Relief Work amounted to Fr. 1,158,082.45, to which has been added the net product of the 1952 collection in Switzerland.

The particulars of relief supplies distributed by the ICRC in 1953 will be found on Page 39.

The balance of the General Account for Relief Work, as on December 31, 1953, amounted to Fr. 1,815,962.34 (see Balance Sheet, Table I, A) ; the estimates for expenditure in 1954 have been summarized in Table VI.

The ICRC would like to express its warmest thanks to all donors for the kind interest they have always shown in its work, and for their generous support.


