ber); in the First Seminar of African Red Cross and Crescent Societies on the Dissemination of International Humanitarian Law (11-26 August, in Mombasa); in the October meeting in Sofia organized by the Bulgarian Red Cross on the theme "Red Cross propaganda and information"; in the Workshop for Editors of European National Societies (13-16 November, in Warsaw); and in the First Asian Seminar on Humanitarian Law (14-24 November, in Kuala Lumpur).

An international tribute was paid to the International Red Cross for its public relations activities: the Prize of the President of the International Public Relations Association (IPRA) was awarded for 1978 to the International Red Cross (International Committee of the Red Cross and League of Red Cross Societies). This prize, awarded annually to an international organization having made an outstanding contribution to develop better understanding in the world, was presented on 14 September by the Association President, Mr. Denis Buckle, to the President of the ICRC, Mr. Alexandre Hay and to the League Secretary-General, Mr. Henrik Beer.

The International Review of the Red Cross

In 1978, as in previous years, three main editions of the International Review of the Red Cross were published—in English, French and Spanish—each of about sixty pages. An abridged version in German of about 16 to 20 pages, comprising a selection of articles which appeared in the main editions, was also printed. On the other hand, for financial reasons, the number of issues was reduced by half. In 1978, therefore, the Review appeared once only every two months instead of monthly and did not contain any photographs.

The Review continued, however, to fulfil its essential functions as the official organ of the International Red Cross and the leading Red Cross journal specializing in international humanitarian law.

In 1978 it printed the ICRC's "Appeal for disarmament" and its "Appeal on the occasion of the entry into force of the 1977 Additional Protocols", also articles on "The ICRC and Disarmament", "The Protection of Victims of Disasters" and "Fundamental Rules of Humanitarian Law applicable in Armed Conflicts", as well as a series of eight articles under the general title "The ICRC, the League and the Report on the Re-appraisal of the Role of the Red Cross".

In addition to publishing articles by various authors on subjects related to military law and the Red Cross ("New Charter for the League", "In the service of the Red Cross", etc.), the Review commemorated the 150th anniversary of Henry Dunant's birth with historical articles and, by way of exception, two photographs—one hitherto unknown—of the chief founder of the Red Cross movement.

Space was given also to news, each issue containing a summary of ICRC operations in various parts of the world, to accounts of the less common activities of National Societies and to an article on the Bulgarian Red Cross centenary. In addition, the Review gave the text of a United Nations resolution on incendiary weapons and published reviews of eight recent works (in seven languages) on international humanitarian law and on the Red Cross.

In this way, the International Review of the Red Cross continued to be the organ linking and providing information for the members of the International Red Cross.

PERSONNEL

In 1978 the staff strength at *ICRC headquarters* varied between 245 (in April) and 265 (in October), with a monthly average of 257. Included in this average, which was six more than in 1977, there were about 80 people whose work was directly related in one way or another with field operations. The work of the remaining employees was related to activities of the Central Tracing Agency, to the development and dissemination of international humanitarian law, to relations with National Red Cross Societies, to information and public relations, to fund-raising, administration, and so on.

The number of persons employed in the field (delegates and technical workers sent from Geneva) averaged 97 per month. The number reached a minimum in January (68 persons) and then steadily increased, due mainly to operations in Africa and Lebanon, reaching a maximum in December (119 persons).

The total number of employees in the field and at headquarters ranged from 324 (January) to 384 (December), with a monthly average of 354.

In addition, the delegations were assisted by *locally employed personnel*, whose number was 174 in January 1978, increasing to 202 in December.

A total of 323 persons were sent on field missions:

- 24 heads of delegation
- 12 regional delegates
- 124 delegates (2 provided by National Societies)
- 59 doctors (12 from National Societies)
- 21 male and female nurses (11 from National Societies)
- 21 delegates of the Central Tracing Agency
- 11 administrators
- 16 secretaries
- 26 radio operators
- 9 technicians

The ICRC organized at Cartigny (near Geneva) four introductory courses for prospective delegates and technicians. These were attended by 98 persons.

FINANCE

Fund-raising

In this respect 1978 was a satisfactory year, with encouraging prospects in view, fund-raising efforts having resulted in increased regular annual *contributions from governments* to the financing of the ordinary budget of the ICRC.

Had exchange rates remained stable throughout the year the total of these contributions would have been 17.6 million Swiss francs, as compared with an estimated 17 million. But, because of the higher rate of the Swiss franc, regular contributions amounted in fact to 16.9 million Swiss francs.

National Society contributions amounted to 1.8 million Swiss francs, exceeding the budget estimate by 113,000 francs. Had exchange rates at the end of the previous year been constant for 1978, the surplus would have been 169,000 francs, so that the exchange difference resulted in a loss of 56,000 francs.

In addition, several governments and National Societies remitted extraordinary contributions amounting to 2,293,000 francs. In some cases, negotiations undertaken in 1978 will not bear fruit until 1979. This is the case, for instance, with contributions to be paid by France, Canada, Japan and the United Kingdom, who are expected to provide altogether 845,000 Swiss francs more than they contributed in 1977.

The *private sector*, too, responded to the ICRC's need for funds. Donations reached 1,755,000 francs, of which 465,000 francs came from Swiss industry and commerce.

American Foundations donated 180,000 Swiss francs.

Thanks to its constant efforts since 1974, the ICRC today is finding that governments, National Societies and other donors better understand its problems and financial needs. For 1978 its total receipts amounted to 24.55 million Swiss francs as against 22 million in 1977, an increase of 11.7 per cent (see Tables II and III).

Balance Sheet and expenditure and income

Balance Sheet

The Balance Sheet total at the end of 1977 was 21,984,000 francs, while that for 1978 amounted to 27,382,000 francs, an increase of 5,398,000 francs.

This exceptionally large increase is reflected in *cash resources* and arises from the funds made available to the ICRC for the discharge of its action programmes, mainly in Africa. This explains also why the item *Advances to Delegations* rose from 1,541,000 francs at the end of 1977 to 2,758,000 at the end of 1978.

On the other hand, short-term investments fell from 10,044,000 francs at the end of 1977 to 7,143,000 at the end of 1978, as a result of a market situation in which the interest on a current account equals that earned on short-term investment. Similarly, as a result of the instability of the dollar, especially during the fourth quarter of the year, investments in that currency were kept to the very minimum.

Because of this situation, liquid assets, including demand deposits, rose from 3,188,000 francs at the end of 1977 to 8,266,000 at the end of 1978. On the *liabilities* side of the balance sheet the Fund earmarked for current operations which rose from 10.03 million francs at the end of 1977 to 14.52 million at the end of 1978, indicates the origin of the increase in the resources available to the ICRC.

Bearing in mind the weakness of its financial reserves, the ICRC in recent years has applied a very prudent management policy. It was able, accordingly, to increase slightly the reserve to 6 million francs by 31 December 1978, but this is still a very modest amount.

Expenditure and Income

Total expenditure amounted to 49,597,000 francs, divided almost equally between ordinary account and extraordinary account.

Compared with 1977, when total expenditure was 41,551,000 francs, the increase was 8,045,000, of which 6,080,000 was entered in the extraordinary account and 1,965,000 in the ordinary account. This total increase of 19.36 per cent well reflects the expansion in all ICRC activities in 1978 and gives an idea of all the problems which had to be solved in each of its departments.

Special Funds

Fund for Current Operations

According to the detailed figures shown in Table X, this Fund includes:

- the amount available to the International Committee for relief actions linked to activities of which the cost is drawn from the ordinary expenditure account, i.e. 778,882 francs;
- the amounts earmarked for activities covered by the extraordinary expenditure account, i.e. 14,520,208 francs.

The annual public collection in Switzerland, which brought in 574,338 francs in 1978, is one of the sources of revenue for relief actions and constitutes a large proportion of the balance of 778,882 francs carried forward to 1 January and mentioned above

The amount from the public collection is thus entirely assigned to relief programmes without any deduction for overheads, which are charged to the ordinary expenditure account (see Table II, pp. 70-71, item amounting to 142,874 francs).

Other funds

The balance sheets and expenditure and income accounts of other funds managed by the ICRC are shown on pages 83 to 87.

Auditing

As in past years, all ICRC accounts were audited by the Société fiduciaire OFOR SA, appointed by the ICRC in accordance with its Statutes.

The auditor's letter proposing that the 1978 accounts be approved is reproduced on page 88.
