FINANCE

Balance sheet

As was already the case at the end of 1980, the balance sheet as at 31 December 1981 showed a marked increase over the previous year.

The balance sheet total in fact rose from 39.4 million to 52.4 million Swiss francs, representing an increase of 13 million, or a third of the previous total, owing to the ICRC's increased commitments in conflict areas. In financial terms, this tendency is marked by the provision of funds whose use was spread over a period of several months and, in many cases, beyond the end of the financial year. In this way, the total funds available for actions involving special funding rose from 15.3 million at the end of 1980 to 26 million at the end of 1981.

This increase of approximately 10 million Swiss francs is reflected in the assets under the headings "Cash" and "Other current assets".

It should also be noted that on the assets side of the balance sheet, the increase in the item "Buildings" has risen to 3.8 million, as compared with 2.5 million at the end of 1980. The reason for this is the completion of the work which had been going on for more than two years to provide the headquarters with the additional offices which its increased activity required.

In the Annual Report for 1980 mention was made of the difficulties encountered in financing actions in Nicaragua, El Salvador and the Lebanon. The situation with regard to El Salvador improved during the course of 1981, but the ICRC's commitments in the Lebanon (Sw. fr. 5,034,139) and Nicaragua (Sw. fr. 1,836,112) still show a deficit of Sw. fr. 147,467 and Sw. fr. 1,362,144, respectively. Hoping to avoid jeopardizing its work in the future by carrying forward such a substantial deficit, the ICRC decided to absorb the latter amount in its income and expenditure account. The extreme difficulties it was experiencing in financing the Iraq and Iran actions made this decision even more necessary. On 31 December 1981, therefore, outstanding expenditure amounted to Sw. fr. 772,337 and this has been carried over as a provisional deficit.

As the future financing of these two actions, particularly in Iraq and Iran, is not guaranteed, the ICRC has decided to set up a fund of one million Swiss francs to meet any increase in these deficits which may occur in the future. The ICRC will also undertake intensive fund-raising activities in 1982 to cover the expenses of these two actions, as well as the deficits amounting to Sw. fr. 919,804 which were carried over from previous years.

Income and expenditure

The income and expenditure account has been balanced by offsetting the deficits from the Iraq-Iran and Lebanon actions by a provision of equal size.

This result is due partly to controlled expenditure, which amounted to Sw. fr. 267,000 less than the budget forecast, and partly to a very marked increase in receipts to 42.2 million Swiss francs, i. e. 14% above the amount forecast.

This exceptionally good result is due to a noticeable increase in contributions from certain governments and National Societies – as can be seen in the next section which deals with financing – and in a smaller degree to the very high interest rates on the money market in 1981.

Another reason for the improvement in Swiss franc receipts was the dollar parity which was higher in the first six months of 1981 than had been predicted at the end of 1980.

In view of the exceptional results obtained in 1981, it has been decided to set up a number of funds to cover current risks (claims) and to meet the commitments made during 1981 whose deadlines will fall only in 1982 or later (studies, equipment and buildings).

Financing

GOVERNMENTS. Despite the economic difficulties experienced by most donor countries there has been an encouraging increase in governmental contributions towards the regular budget. More frequent contacts with public authorities, as well as numerous missions, have contributed to this. Particular mention should be made of action undertaken in the U.S.A., Italy, Austria, Belgium, Tunisia, four Persian Gulf States, twelve countries of Latin America and two Eastern European countries.

It should be mentioned that 50% of the 151 States parties to the Geneva Conventions made a contribution in 1981. This situation cannot, however, be considered satisfactory. At the Twenty-fourth International Red Cross Conference in Manila in November last another appeal was made to all governments, asking them to guarantee adequate financial support for the ICRC each year and recommending that a new item to cover regular financing of the ICRC's humanitarian activities be included in their budgets (Resolution XVII).

Contributions in 1980: Sw. fr. 27.4 million (of which about 3 million represent non-recurring extraordinary contributions, paid direct into the General Reserve).

Contributions in 1981: Sw. fr. 33.3 million (of which about 3 million still had to come in on 31 December).

NATIONAL SOCIETIES. Encouraging progress can be recorded here. Sixty-eight of the 126 National Societies recognized at the end of 1980 paid the sum of 2.6 million Swiss francs to the ICRC in 1981, an increase of Sw. fr. 400,000 over 1980.

At the International Conference in Manila a re-examination was made of the methods used by National Societies to finance the ICRC and a resolution proposing new solutions was adopted. The Commission for the Financing of the ICRC will examine the possibility of applying this resolution as from 1982 and until the next meeting of the Council of Delegates (Resolution XVIII).

Auditing

As last year, the accounts have been audited by the Société Fiduciaire Suisse. On page 111 of this report appears a photocopy of their letter proposing that the Committee should approve the balance sheet and the accounts for 1981.
