* Meeting in ordinary Assembly on 3 and 4 December 1986, the ICRC welcomed a new member: Mr. Cornelio Sommaruga, future President of the institution, who in July 1986 had accepted the ICRC's invitation to take the institution's highest office. On 7 May 1987 he will succeed President Alexandre Hay, who is to step down after more than ten years at the head of the ICRC. Mr. Cornelio Sommaruga previously held a prominent post in the Swiss Federal Administration, that of Secretary of State for External Economic Affairs.
