# INTERNATIONAL ADVISERS

Since 1984, the ICRC has held two meetings a year with a dozen leading international figures selected for a four-year period to advise the institution on operational matters, on the application of international humanitarian law and on the ICRC's place within the international community.

In 1995, this group of international experts met in March and September. Its discussions focused on preparations for the 26th International Conference of the Red Cross and Red Crescent, communication in the humanitarian sphere, displaced persons, the question of the protective emblem and various operational matters. As its mandate was coming to an end, the group also reviewed the work it had accomplished over the past four years.
