SWISS EMBASSIES IN FOREIGN COUNTRIES.

On account of the recent devaluation of the Swiss Franc, the Federal Council of Switzerland has been forced to increase the allowances of our many Embassadors. Although the increase is less than the actual devaluation, the percentage varies between 15 and 20%. It may interest our readers to know some of the figures allotted in large capitals :

The total of the increase for all Embassies and Consulates has been calculated to be approximately 1 Million Francs.
