made, the competent local authorities, namely the Town Clerks (City Emergency Scheme) of the cities or towns where prospective evacuees are living, should be informed accordingly, both by the hosts and guests. This is most important for the authorities to know, because in case of an evacuation emergency transport facilities will be arranged by the evacuation authorities.

It would be advisable as well to keep the Secretary of the Swiss Benevolent Society, Mr. Herman Schlatter, 2nd Floor, T. & G. Building, Wellington, C.l., informed of such arrangements; also there may be cases, where the Committee may even be of assistance in concluding such evacuation arrangements between our fellow countrymen in the country and urban centres. It goes without saying that if members of the Society will write to the Committee in this respect, such requests will find prompt attention.

KEEPING IN TOUCH WITH EACH OTHER IN CASE OF EMERGENCY.

Arrangements should be made by all our fellow-countrymen in New Zealand, which would enable them in case of a national emergency to keep in touch with each other, so that at any time a check up can be made as to the well-being of everyone. Instances might arise, where immediate help and assistance, or advice, should be offered to compatriots: (a) by local Swiss groups; (b) by the Committee of the Swiss Benevolent Society at Wellington; and (c) by the Consulate of Switzerland at Wellington.

The Swiss Consulate at Wellington attaches the greatest importance to be informed, during or after any emergency, of the well-being of all our fellow-countrymen throughout New Zealand, and expects that such information would be passed on to it immediately the occasion arises, either by individual Swiss citizens or local Swiss groups.
