IMPENDING DEPARTURE OF MR. MARCEL ROTH, AUCKLAND.

Our members, and especially those at Auckland and Wellington, will be sorry to hear that Mr. Marcel Roth, who was one of the active committee members at Auckland, is making arrangements to leave New Zealand.

From the date of his arrival in New Zealand in January, 1940, Mr. Roth has taken a keen interest in the Swiss Benevolent Society of New Zealand, and he has endeared himself as a true friend and good compatriot to his fellow-countrymen who had the privilege to know him.
