AND EUROPE OF TODAY

The Delegates of the European Union, Swiss Movement for the Unification of Europe, met in Zofingen. After a public meeting in the Town Hall which was under the Chairmansjip of the City Mayor, Mr Lerch, the former national and Government Councillor, Heinrich Schnyder made a speech entitled "Economic considerations for the Unification of Europe". He explained the aspects under which Switzerland should look for co-operation in the economic field in the new European Federation. The President of the Movement, Dr. H. Bauer, spoke about Switzerland and the European Council of Strassburg. Lively discussions took place and Switzerland's situation was examined in a ciritical manner. The discussion resulted in the acceptance of the following resolution:-

"The Delegates of the European Union, Swiss Movement for the Unification of Europe, stressed that the future of Switzerland depended largely on the development of Europe. They welcome with satisfaction the beginning of a closer relationship of all European peoples of which the European Council of Strassburg is the first expression.

They are sure that through active collaboration Switzerland can give a positive contribution to the recuperation of Europe and at the same time protect its own historically based special position.

They recognise that the Statute of the European Council, of which all authority regarding military questions are excluded and which does not have any diminishing of sovereignity of its member states, does not prevent participation of Switzerland in as much as its tradition is concerned. The Assembly unanimously decided to notify the Federal Council first to explain to the Federal Chamber, as well as to the Public, the importance and the effect of the Statute of the Council of Strassburg on Scitzerland, Secondly, to send a permanent official observervatory Delegation to meetings of the European Council in Strassburg, thirdly, to considerin which way Switzerland can immediately take part in the work of the Europe n Council, and fourthly to prepare early accession of Switzerland to the European Council".
