## GENERAL MEETING OF SWISS BENEVOLENT SOCIETY

### Extracts of Report

Approximately 15 members attended the Annual General Meeting held on October 29th, at Mr. Komminoth's Tearooms, Victoria Street, AUCKLAND.

MINUTES: Last year's minutes were read by the secretary and confirmed as carried by the meeting.

MEMBERSHIP FEE: As published in the "Helvetia" a year ago, the previous general meeting decided to raise the annual subscription from 10/- to 15/- per annum, subject to member's approval or disapproval, either in writing to the secretary, or else simply paying the increased fee which would automatically imply acceptance. No written objections were received and the increased fee was actually paid by more than 75% of the members. Thus the annual subscription is now 15/-.

BALANCE SHEET: With a few explanatory remarks the annual balance sheet was presented to the meeting by the President, Mr. A. Peyer, and was adapted as carried.

ELECTION OF COMMITTEE: Members of the past year's committee were all willing to stand for re-election, and the secretary having received no new nominations whatever, the following have been elected:

**HELVETIA:** The increased expenses to publish our little paper gave your Committee some anxiety, and a year ago it was suggested that one way to decrease costs would be to publish the "Helvetia" only every second month. Through the increased fee and the donations made by members, however, we are now able to maintain the monthly publication as in the past.

A special motion was proposed by Miss W. Keller and seconded by Mr. Steyer, namely: "That the Swiss Consul should endeavour to sustain constant contact with the Colony and for that purpose he should be invited to meet his compatriots in Auckland at least once a year, and when doing so to inform the secretary of the Society not less than 10 days in advance."
