ANNUAL REPORT

1st OCTOBER, 1950-30th SEPTEMBER, 1951.

Once again your Committee takes the pleasure of presenting the Annual Report and Balance Sheet. The past year has been quiet. No calls have been made on our funds for any financial assistance, on the contrary, the Society had the fortune to have a sum of money donated by the father of a deceased member.

We are sorry to say that we have lost 11 members through death or resignation, on the other hand 26 compatriots have joined the Society during the year. The membership list now totals 221.

General Expenses remained about the same as last year £8/8/6, 1950 £11/13/4. The printing of the "Helvetica," however, has risen to £125/18/6.

Now, if readers will bear with me a while longer I would like to right some misconceptions that apparently exist regarding the Society and its Committees. It has come to our notice, for instance, that we, the Committee, do nothing but hoard the moneys collected. If so far no calls have been made for financial assistance, well, that is our good fortune, and if there have been cases among our countrymen that needed assistance, let me assure you the Committee had no knowledge of them. I may intimate, however, that this year there are already two cases where financial support was given.

It has also been said that the Committee squanders the funds on entertainments. This misconception no doubt has arisen because there has existed in Auckland, since 1951, a Swiss Social Committee, but, unfortunately, owing to the small numbers of compatriots here, some of us have to act on both Committees. Banking accounts, however, are kept strictly separate, and in different hands. Incidentally, owing to lack of interest, no social functions were held during the last two years and the Committee was practically non-existent, but now, with the influx of new blood, we hope that past activities will again be taken up.

Any organised social functions among our compatriots must of necessity be locally arranged, and the S.B.S. as a country-wide organisation cannot give any financial assistance. Paragraph 2 in the Rule Book will make this clear.

I hope I have been able to clear any misfeelings some of our members may have had and that they will give us their wholehearted support in the future.

In conclusion, I wish to thank my Committee and especially Mr. Merz and the Swiss Consulate for all they have done for our Society.
