WELLINGTON SWISS CLUB

The Annual General Meeting of the W.S.C. was held at the Brooklyn Hall on April 30th, 1960. The president was delighted to welcome our Consul-General, Dr O. Rossetti, Mrs Rossetti, Mr W. Sollberger (Vice-Consul), Mrs Sollberger and the greater part of our members.

A special word of welcome to introduce Dr Rossetti was followed by a talk by Dr Rossetti. Our Consul-General expressed he and his wife's thanks for the invitation. He then outlined the responsibility each of the club members has, as they are all in a way ambassadors for our home-country. Dr Rossetti also pointed out the difficulties the Swiss abroad encounter and assured us that our Magistrates in Switzerland do their best to help the fifth Swiss. To illustrate this trend of help and understanding, Dr Rossetti gave a few examples and mentioned thus the Solidarity Fund, the introduction and facility with the A.H.V. as well as the new regulation regarding Swiss Army Tax. Dr Rossetti stated that Switzerland looks with pride on its countrymen abroad and he, Dr Rossetti, his wife and his staff will do all in their power to help us Swiss as much as they can. A sombre point in his talk was indeed the mentioning of the death of four of our country's great people, especially General Guisan, who passed away at the age of 86. There is no doubt about the debt we all owe to General Guisan, since he, by his leadership and courage, saved our homeland during the last war. To honour this great man Dr Rossetti asked all to stand for a minute's silence.

In conclusion, Dr Rossetti assured the Club of his help and understanding and expressed the wish that the good relationship that existed between this Club and the Consulate may remain also in the future.

The president thanked Dr Rossetti for his very interesting and kind talk. In his summary about the Club's expiring year, the president pointed out that the committee held not less than 14 meetings, while the Club itself had six indoor meetings, three picnics and some Jass-evenings as well as one music evening. He urged members to take a greater part in the activities of the Club and not to act so much just as receivers. The president also made it clear that the committee did an excellent job, for which he expressed his heartiest thanks, but he stressed that the committee alone should not be expected to do the work. The present membership number totals 78, slightly above last year's 72.

The treasurer was able to surprise most members by announcing that the Club's assets were £90/11/9½ in cash and roughly £15 in crockery, etc. There was no doubt of this after the treasurer's well-informed balance sheet, which was audited by Mr Sollberger very carefully, had been read.

The president then outlined the activities of the coming Club year. By far the greatest—and the most heated—argument arose when the president struck the theme, "Helvetia." There is no doubt, it was a Swiss General Meeting, as Swiss as it could be—with all its pros and cons. The final result was that the Club fee of 8/- per year be raised to £1. The Club will ensure that each member receives the "Helvetia," or, in case of a family, one "Helvetia" for each household.

Supper time arrived all too soon and this gave members an opportunity to meet our new Consul-General. Films which were later screened helped to make this evening not only a memorable, but also an enjoyable one. —K.E.B.
