### Annual General Meeting

The Annual General Meeting of the Swiss Society was held in the Riverlea, Hamilton, on Sunday, 11th June.

The Hamilton Swiss Club was host to the 80 odd visitors and members. As the delegates we welcomed Mr Schaefer, from the Consulate, and Mr Wehrli, from Wellington; Martin Steiner, Joe Dettling and Louis Kuriger, from Taranaki; and Mr Binder, Doris Peyer and Joe Wildhaber, from Auckland.

The alterations of the Rules as proposed were adopted. In spite of the deficit shown in the balance sheet, due to the non-payment of subscriptions (£70), the meeting decided to keep the subscription of the "Helvetia" the same as last year.

The Steinstossen Trophy was won again by Taranaki and received by their leader, E. Wuetrich.

Election of officers resulted as follows: President, Walter Risi; vice-president, John Steiner; secretary, Arnold Biland; treasurer, Hans Oettli. Each Club is entitled to three delegates. Press committee, Walter Risi, Arnold Biland, Hans Oettli and Ernst Studer; auditor, Mr Cooper, Huntly.
