Federal Councillor Wahlen expects one of the Chambers to deal with the Article in the December session and the other in March 1966. The federal plebiscite could then take place in the autumn next year.

At a Press Conference given by the Secretariat for the Swiss Abroad of the N.S.H., satisfaction was expressed, though the draft Article differs, mainly in formulation, from that submitted by the Commission. Provided it is accepted by Parliament, the Article will be a considerable milestone in the relations between Switzerland and her nationals abroad.

FUNCTION MARKS SHIP'S CHANGE OF NATIONALITY

With the first Swiss immigrants to New Zealand settling in Taranaki it was appropriate that the transfer of the motor vessel Castasenga's nationality from Liberian to Swiss should take place at Port Taranaki, the Swiss charge d'affaires in New Zealand, Dr Jean-Pierre Weber, said on board the ship last night.

Dr Weber was addressing about 40 guests who attended a cocktail evening aboard the Castasenga to mark the change of nationality which has resulted in the Swiss merchant navy being increased to 32 vessels.

The ship arrived at Port Taranaki yesterday flying the Liberian flag and bearing the name *Cruzeiro Do Sul* and owned by Maranava Ltd. a Swiss-owned company that had the ship registered in Liberia. The official transfer of ownership to the Oceania Shipping Co., another Swiss-owned company which has registered the ship in Switzerland, took place yesterday.

Symbolic

Dr Weber said the presence of the *Castasegna* in New Zealand waters was symbolic of the increasing trade between the two countries. He was pleased to see that New Zealand was giving increased attention to diversifying trade outlets and he would like to think that Switzerland offered possibilities.

Referring to the migration of Swiss nationals to New Zealand, he said their numbers had increased in New Zealand and many had become New Zealand citizens, combining in a most impressive manner a deep loyalty to their new country with a faithful attachment to the old.

The Swiss had always been very good citizens, said the mayor of New Plymouth, Mr A. G. Honnor, in reply, while the chairman of the Taranaki Harbours Board, Mr H. E. Blyde, echoed Dr Weber's desire for increased trade with Switzerland.

The president of the Swiss Society of New Zealand, Mr J. Steiner, New Plymouth, spoke on behalf of several members of the society present at the function.

The *Castasegna* will sail for Newcastle tomorrow.
