## SWISS SOCIETY OF NEW ZEALAND ANNUAL GENERAL MEETING

THE Annual General Meeting of the Swiss Society of New Zealand was held on Sunday, 4th June, 1967 at the Matterhorn Coffee Lounge in Wellington.

Those present were: Dr J. P. Weber, Committee Members Messrs John Steiner, Hans Schaerer, L. Kuriger, Hans Oettli, Arnold Biland. Delegates from other clubs were: Messrs J. Villiger (Hamilton), T. Sidler (Auckland), L. Chamberlain and M. Steiner (Taranaki). Also present were all members of the committee of the Wellington Club, members of the Hamilton Jodelchoerli, and a good representation of the Wellington members.

The President's Report and the Balance Sheet revealed that the financial position was not sound and our paper, the "Helvetia," was not paying its way. With printing costs up again this year, the paper was losing £100. A lively discussion took place about how to rectify this unfortunate state of affairs. Most members felt that all clubs should make it compulsory for their members to contribute to the "Helvetia" (as had been decided years ago at a previous Annual General Meeting). Also, Mr Biland was asked to enquire into size of paper and quality of printing in view of reducing costs and report back to the committee. It was decided to keep the subscription fees at their present level.

Election of the new Committee resulted: President, Mr Karl Bischof. Vice-President, Mr Anton Tresch. Secretary-Treasurer, Mrs Ruth Messmer. Auditor, Mrs Lotti Napp. Editing Committee, Messrs Arnold Biland, Hans Oettli, Walter Risi, E. Studer. Rifle Master, Mr Hans Oettli.

Dr Weber thanked the editing committee for their good work which was appreciated. A copy of the "Helvetia" was regularly sent to Berne and read there. It gave a good picture of the life of the Swiss community in New Zealand and strengthened the link between the Swiss. Mr Biland thanked Dr Weber for his kind words and pointed out how important it was for the news to reach him by the 10th of each month.

Mr Oettli reported that the number of competitors taking part in shooting competitions had been steady for years at about the 100 mark. He also suggested that competitors who already have one Kranzabzeichen might prefer a silver spoon next time they qualify. The spoons had been ordered in Switzerland and should be here in time for the 1st August.

The Trophy for the best group went for the first time to Taranaki, whose President, Mr L. Chamberlain, accepted it on behalf of Messrs Fluehler, Kaiser, Napflin and Rubli.

Mr A. Biland, as New Zealand delegate to the Auslandschweizerkommission in Berne, made an appeal to members to join the Solidarity Fund. Especially Swiss in relatively "safe" countries
