A HAMILTON SWISS CLUB

The Club's Annual General Meeting took place on Saturday, 12th April, in the Swiss Chalet.

The President, Mr John Villiger, opened the meeting and thanked those present for their interest and support; the attendance was quite pleasing and he hoped that those who were not present were happy with the running and management of the Club.

In his report to the meeting Mr Villiger touched on the high-lights of the year, the annual dance, the picnic and card evenings, and said that the financial position of the Club was not only sound but prosperous, thanks to the efforts of the Treasurer, Mr J. von Holzen, and Mr Hans Oettli, who took over the Treasurer's job during Mr von Holzen's absence in Switzerland.

Afterwards, it was moved that the President's report and balance sheet be adopted, and Mr W. Mueller as entertainment officer, Rinaldo Rust was elected. Messrs W. Unternahrer and Hans Meister were elected Riflemasters.

Under Correspondence a letter from the President of the Swiss Society, Mr Karl Bischof, urging the Club to look into the matter of the proxy voting at the annual general meeting of the Society, a very lively discussion took place for the best part of an hour. After looking at it from all angles it transpired that abolishing proxy voting would deprive all members who do not belong to an affiliated club of the right and opportunity to vote. Considering that 190 of the 402 Society members do not belong to an affiliated club, to change the annual general meeting into a meeting of club delegates is most unfair to nearly half of the members. After all, the Swiss Society is not a Society of clubs, but a Society of members. The annual general meeting of the Hamilton Swiss Club then voted unanimously in favour of retaining the proxy system.

To conclude the evening everyone enjoyed an excellent supper a la Swiss Chalet.

The Annual General Meeting of the Wellington Swiss Club took place on Saturday, 29th March, 1969, in the Victoria League Hall. Fifty-two members were present.

Before the meeting proper, a Cocktail Party was held in honour of our new Ambassador, Mr M. Corti. In a short speech, Mr Corti told the assembly how pleased he was to be in New Zealand and what great importance he attached to mutual trust and confidence, so that the Embassy can work in the best interest of the Swiss people in New Zealand.

Hedy's Corner

- 1. If you are a new arrival here and need a doctor, ask around the neighbourhood or pick the one nearest you from the list at beginning of phone book.
- 2. You should not go to a doctor who is called "physician", "surgeon", or by any other prefix. These are specialists and only your family doctor, called a G.P., should refer you to a specialist.
- 3. The patient is at liberty to ask G.P. for a 'second opinion'. Similarly the family doctor may refer his patient for a second opinion, if he feels this advisable.
- 4. If at Home you were looked after by a homoeopath or someone specialising in natural healing treatment, you should know that these are unobtainable here from a qualified doctor. These branches of medicine are not normal practice in N.Z. medical schools, nor taught at post-graduate courses.
- 5. You cannot take a "cure" at a spa, such as at Rheinfelden or Baden, they do not exist as such, except in Rotorua for rheumatic and arthritic conditions.
- 6. G.P.'s fees vary somewhat, depending on the service given. Specialists fees are considerably higher and also vary for service given.
