★ NEWS FROM THE EMBASSY

IMPROVEMENTS OF THE OLD AGE PENSIONS SINCE THE YEAR 1948

The Federal Old Age and Survivors' Insurance benefits are today in all cases a manifold of the rates existing at the very beginning. After the recent 7th revision, the minimum old age pensions for single and couples has been increased by 400% and the maximum is now 220% higher than at the time of introduction of this insurance scheme. The survivors' pensions have benefited from an even more noticeable improvement. These

pensions are now increased by 412% (minimum) and 284% (maximum). The pensions for widows have been augmented between 562% (minimum) and 433% (maximum), and the corresponding percentages for orphans would now be 570 respectively 433%. In view of the fact that Switzerland's consumer index has increased by 47% during this lapse of time, the purchasing power of the old age pensions is presently between two to four times higher than in the year 1948.

It can be expected that this trend will also be observed in the years to come; the accession to this insurance scheme can therefore be warmly recommended and the Embassy will gladly give further details.

To be complete, it should be added that the contributions have been increased to 5.2% to be calculated on the gross income of the employed persons.
