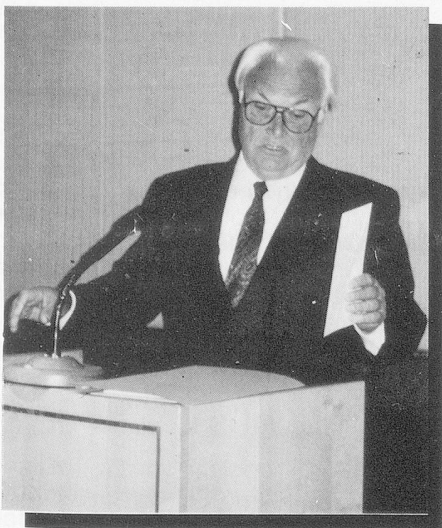

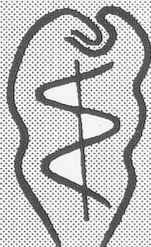

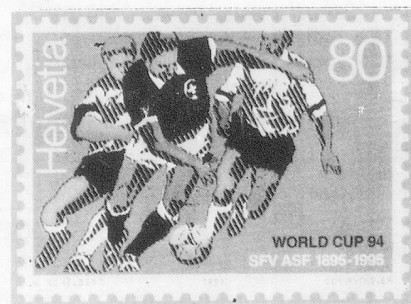

FOOTBALL WORLD CUP 1994

Switzerland's football team has qualified for the finals of the 1994 World Cup being staged in the USA. The first such qualification after a break of 28 years is a remarkable accolade for the Swiss Football Association (SFV), which currently has over 200,000 members, 110,000 of them juniors. It is also a well-deserved reward for the hard work put in by all the Association's clubs and branches. The SFV hopes that this success will lead to wider recognition of its efforts within Switzerland. Much of its work is targeted at young people, as it is keenly aware of its social responsibilities and is eager to contribute to the life of the community. The finals of the 14th World cup will be held in the USA from 17 June to 17 July 1994. The cities of Detroit, Los Angeles, San Francisco, Chicago, Dallas, Boston, New York, Washington and Orlando will play host to this unique sporting spectacle, whose size and international importance are surpassed only by the Olympic Games. It is a wonderful opportunity for the SFV to not only represent Switzerland, but also assist in better acquainting the American public with the sport which is so popular across Europe. What is more, this long-awaited World cup qualification makes a wonderful birthday present for the SFV, which is about to celebrate its centenary in 1995. The stamp designed by Hermann Schelbert from Olten shows a typical football scene illustrating the dynamism of the hard-fought team sport. At the same time it draws attention to the 1995 centenary of the Swiss Football Association.



MUBA STAYS IN BASLE

After years of discussions the famous "Basler Mustermesse" or "Messe Basel" as it is called now will remain in Basle after all. Plans had been made to move the whole operation over the border into France where there was more and cheaper land available (see our report in the Helvetia of January 1993). Finally the Basle City Council found that it had neither the willpower nor the money to implement this proposed expansion and so things remain as they are.
