## NEWS FROM THE EMBASSY

### NEW UNFORGEABLE IDENTITY CARD

#### WRITTEN IN FIVE LANGUAGES

The new unforgeable identity card will be issued in the four national languages and in English. The Federal Council has adopted the ordinance relating to the Swiss identity card and it will come into force on 1 July 1994. The experimental phase will be put into place in German-speaking Switzerland on 1 July 1994 in the towns of Adliswil, Berne and Zofingen, and will be followed from 1 September 1994 in French-speaking Switzerland in the towns of Délémont and Lausanne.

The conception and presentation of the new plastic document, secure from forgeries, the format of which corresponds to that of a credit card, has received an extremely positive welcome during the consultative procedure. Some reservations remaining concern questions of detail, such as the language used for the inscriptions or the protection of information. Maintaining the "Einheimischenausweis" which enables holders to obtain tickets at a reduced price, has equally been requested.

With relation to the problem of the languages, the Federal Council has, for the sake of internal politics, decided that the inscription appearing on the new card will be printed in the four national languages, but also in English, in order to guarantee acceptance abroad. The central seizure of information by the Federal Office of the Police (OFP) is aimed at preventing one person from delivering several cards and of accelerating the procedure for replacement cards, notably abroad. There is no connection between their system of information data and other banks of information or services. The Federal departmental head for the protection of information has approved this measure. The "Einheimischenausweis" which until now has been combined, will be issued independently of the identity card, and will be from now on delivered under the autonomous cantonal attestation form of domicile indicating the relevant district.

**Staggered Replacement of the Present Identity Card.**

The replacement of the current brown/beige identity card will be carried out at staggered intervals. The new document will firstly be delivered to citizens whose current card falls due or who are not yet holders of an identity card. The new identity card will have to be requested personally from the relevant register, on presentation of an authorisation of domicile or, in the case of falling due, the old card together with a black and white or coloured photograph. The price of the new card must be paid at the time of the request: it is 35 SFR for adults and 25 SFR for children up to 15 years of age. The document will

be sent within 3 days, by registered mail, to the holder's home. As soon as the trial phase is finished in the towns mentioned above, the card will be introduced to the various cantons in a specific order.

#### INVITATION

In conjunction with the Werner Bischof Photographic Exhibition from Switzerland which will be touring New Zealand over the next year or so, Dr. Peter GERDES, Sydney-based correspondent for Australia, New Zealand and Oceania for the "Neue Zürcher Zeitung" as well as being Associate Professor of Media Studies at the University of New South Wales, will give a talk at the Dowse Art Museum, Laings Road, Lower Hutt, on Friday 5 August at 7.30 pm

The talk will be on the life of Werner Bischof, an explanation of what photo-journalism is/was and a short description of the exhibition. He will also be showing "Wochenschaubeiträge" - the old black and white newsreels filmed from the time of the Second World War and just after.

**Aigantighe Art Gallery**, Timaru: June - July 1995

**Rotorua Bath House Gallery**: August - September 1995
