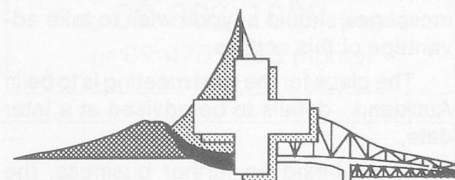
MOTION

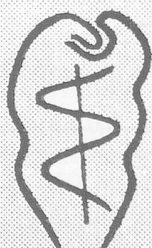

MINUTES OF THE ANNUAL GENERAL MEETING HELD IN WELLINGTON ON SUNDAY 4 JUNE 1995 AT THE OHARIU VALLEY CLUBHOUSE AT 2 PM.

Peter Schüpbach, the vice-president, welcomed everybody to the meeting.

PRESENT

Mr. Hans FITZI (President), Mr Peter SCHÜPBACH (Vice-President), Mrs Carmen GORDON (Secretary/Treasurer) and about 60 other members with voting rights.

The minutes of the last AGM were taken as being read, having previously been published in the Helvetia. Moved by Hans Fitzi, seconded by Marianne Benkert.

The President's Report was read and accepted.

The Financial Report was taken as read, having been previously published in the Helvetia. There was a query relating to the higher postage expenses than the prior year. Moved the report be accepted by Carmen Fitzi-Gordon, seconded by Herbert Staheli.

The Editor's Report was read and accepted.

The Report from the Delegate to the Swiss Abroad was read and accepted.

The Riflemaster's Report was read and accepted.

ELECTION OF OFFICERS

The existing committee was re-elected, there being no resignations.

APPOINTMENT OF SCRUTINEERS

Mr. Herbert Staheli and Mr Ruedi Benkert were appointed as scrutineers

SUBSCRIPTIONS

The committee had put forward the motion that "the number of Helvetia issues be increased to 10 per year and the sub-

scription to be \$25.00 per year per family or per single member.

There was a short discussion concerning the possibility of having more than ten issues but it was pointed out that this could not be done without increasing the price of the subscription even more.

A motion was put that the subscription be increased to \$27.50 for 11 issues a year. This was moved by Max Fuhrer and seconded by Maya Beddie-Geiser.

A vote was held on this motion which was lost by a significant majority.

The original motion was then put to the floor. Moved by Hans Fitzi, seconded by Marianne Benkert. The motion passed with two against.

GENERAL BUSINESS

A request was made to print the new committee members of all the clubs in the next Helvetia.

Mr Hans Fitzi read a letter from an Auckland based German language radio station offering to broadcast tapes and messages should anyone wish to take advantage of this service.

The place for the next meeting is to be in Auckland - details to be advised at a later date.

There being no further business, the meeting closed at 2.30pm.

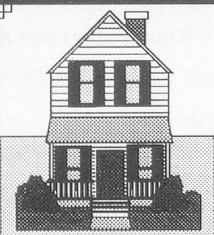
