MINUTES OF LAST YEAR'S AGM OF THE SWISS SOCIETY. ANNUAL GENERAL MEETING OF THE SWISS SOCIETY HELD AT THE NEWMARKET CLUB IN AUCKLAND ON SUNDAY 2 JUNE 1996.

The AGM started at 2.30pm with Peter Schüpbach, Vice-President, welcoming everybody to the meeting.

Present: Hans Fitzi (President), Peter Schüpbach (Vice-President), Henry Sigerist (Editor) and around 70 other members with voting rights.

Apologies: Mr. and Mrs. Hochuli, Mr and Mrs Enzler, Mr and Mrs Stucki, Mr and Mrs Hiestand, Mr and Mrs Dudli, Mr and Mrs Flühler, Mr and Mrs Hartmann.

The Minutes of the past AGM were taken as being read, having previously been published in the Helvetia. Moved by Hans Fitzi and seconded by Syd Melville. The President's report was read and accepted. The President asked the members to stand for a minute's silence in remembrance of several members who passed away during the year.

As each member present at the AGM had been given a copy of the Financial Report, the President simply gave a brief outline of the financiai situation, explaining that the very small loss was due to a drop of income through advertising. The report was accepted unanimously. A question was raised as to the higher costs for printing and typesetting and the President explained that this was due to the larger number of issues published during the year.

The Editor's report was read and accepted.

The report from the Delegate to the Swiss Abroad was read announcing the resignation of Jürg Stucki, the present Delegate.

The Riflemaster's report was read and accepted.

The motion for the number of Helvetia issues to remain at 10 per year and the subscription to remain unchanged was accepted unanimously.

One nomination had been received for a replacement for Jürg Stucki as Delegate for the Swiss Abroad: Heinz Leuenberger. His nomination was accepted unanimously.

The President pointed out that no reports had been received for the past 3 years from the Delegate for the Swiss Abroad on any decisions made in Switzerland affecting the Clubs and the Society. He urged any Swiss visiting Switzerland and attending the "Auslandschweizertag" to report back to the Society.

Marie-Therese Melville-Schöpfer, as Deputy Delegate to the Swiss Abroad pointed out that all items concerning the Swiss Abroad are being regularly reported in the Swiss Revue. She advised that the next "Auslandschweizertag" will be held in Neuenburg on August 23, 1996.

According to the rules, the Vice-President had to step down and a new Vice-President from the club taking over the Swiss Society's affairs the following year had to be nominated. Moved by Herbert Staheli and seconded by Ronaldo Rust, Beatrice Leuenberger was elected as new Vice-President of the Swiss Society.

As there was no resignation from the remaining Committee, Syd Melville moved that the committee be reelected, seconded by Marie-Therese.

It was agreed that Carmen Fitzi-Gordon, although absent from New Zealand, would remain as Secretary/ Treasurer of the Society with Werner Stebler as a co-opted member of the Committee.

Herbert Staheli advised that the Hamilton Club had already selected the Committee members to take over the running of the Swiss Society next year. He announced that Ronaldo Rust will be the new Editor.

GENERAL BUSINESS. Heinz Leuenberger pointed out that for inter-club smallbore shooting competitions, the rules should all be the same. It was decided to leave this matter in the hands of the clubs' Riflemasters to sort out.

Hans Fitzi suggested that it might be a good idea in future for the club presidents and secretaries to meet just prior to the AGM to discuss any matters of general interest to all clubs.

A question was raised as to how many members the Swiss Society had. As the figure was not available, it was suggested to have it printed in one of the future Helvetia issues. The President also pointed out that there was a certain discrepancy between the number of copies sent out to members and the amount of subscriptions received from the clubs. André Schleicher advised that for the cowbell competition, there was no hope for his club ever to be able to compete on even terms with other clubs in the "Steinstossen" competition. He suggested that "Steinstossen" should be replaced by some other sport such as boule (pétanque) as a less strenuous sport. Herbert Staheli replied that the clubs could not always muster their strongest men for this competition and that therefore the odds were more or less even for everyone.
