## **Financial Report**

The higher income this year is mainly due to increase in advertising and subs, but interest has reduced because of fluctuating rates. *Helvetia* production costs are the main expenditure, and only marginally less than last year. The 1997 audit fee was returned as the donation. I am pleased to report that the 1998 financial year ended with a surplus of **\$2725**, and congratulate the editing team for the wariness they have always kept on expenditure levels. For instance, stapling the pages together themselves saves \$90 per issue. Well done!

As can be seen, a savings account has recently been opened. The account is high interest bearing but the funds are on hand when required.

The adoption of this report was carried unanimously by the meeting. My thanks also to Bill Miles for the full audit of the financial records.
