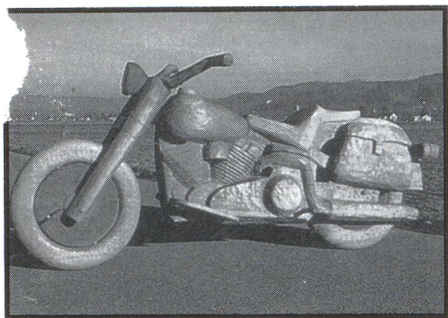

Calls on ABB to withdraw from dam building project in India

The Swiss/Swedish engineering company, ABB, is facing calls to pull out of a dam building project in India. The development organisation, Declaration of Berne, said the project would force more than twenty thousand people from their homes on the Narmada river. The group said several companies in the United States and Germany had already withdrawn from the project due to public pressure.

Supreme court rejects Moslems' right to eternal rest

The Swiss Federal Court has ruled that Moslems do not have the right to eternal rest in public cemeteries in Switzerland.

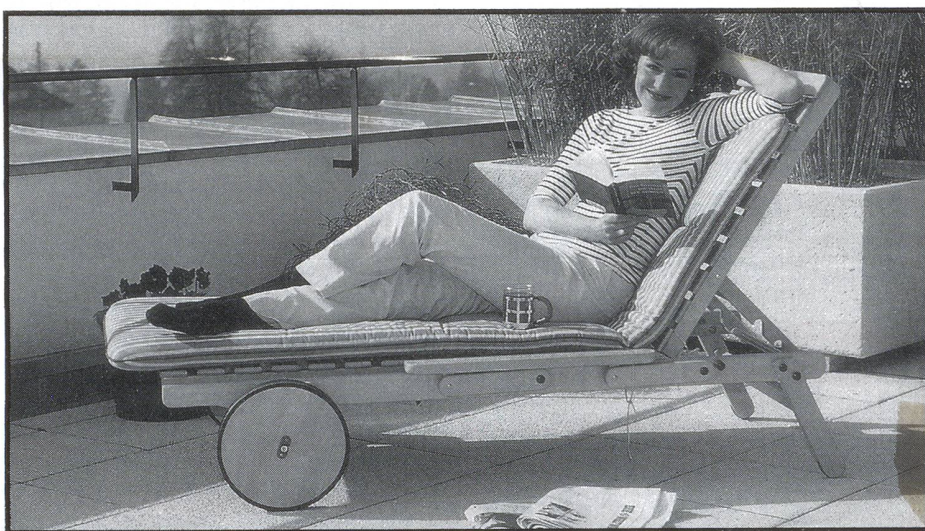
The ruling comes after a Moslem man tried to seek assurances from the authorities that his grave would not be disturbed after he was buried. The ruling re-inforces the current practice, which permits human remains to be exhumed after a few

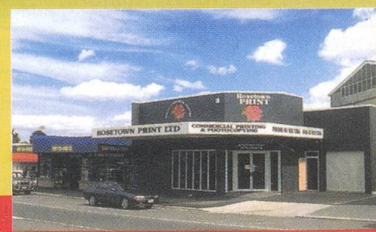
