### WILLY MULLER 1914 - 1999



Willy's journey began in 1914 when he was born in Unterkulm, Kanton Aargau, the third of five brothers. In 1936 he married Grittly forming a partnership that would last 54 years.

After the war they left Switzerland, arriving in New Zealand in May, 1951, a journey which took six weeks on the Orcades.

They first settled in Tatuanui, then moved to farm at Taihoa near Matamata. From Matamata Willy and the family moved to Morrinsville where he began work at the B.L.M. engineering firm until his retirement.

Even though they had journeyed far from Switzerland, Willy and Margaret (Grittli) understandably always retained their special bond to the old country. They spent a good number of years actively involved in the Hamilton Swiss Club particularly as members of the dance group. They enjoyed the fellowship of the Swiss community and the chance to keep their culture and heritage alive.

- Willy was a man who explored and enjoyed new experiences and challenges making the most of his opportunities.

He was a good man, giving his love freely and unconditionally to the entire family, doting especially on the children.

A man who took the time to smell the flowers, uncomplicated, kind, generous, gentle, patient and sociable.

- Willy will be remembered in many ways by many people: as a highly skilled engineer, an inventor, a farmer, goldminer, dancer, armchair politician, friend, uncle, granddad, great granddad, husband and father.

May he rest in peace !

### Alusuisse wants to get bigger...

It's only six months since Algroup's planned merger with the German Firm Viag (no connection with Viagra!) fell through some cracks, and another merger is being talked about.

- According to the Wall Street Journal, Algroup's President Martin Ebner and Managing Director Sergio Marchionne are currently conducting talks with the French Firm PECHINEY as well as with Canada's ALCAN. - Should this merger come about, the new Group, as yet nameless, would become the largest Aluminium Producer on the globe, with a turnover of sfr. 37.5 bil, and a workforce of 102,000.

- Alcan with it's 44 % share will act as the mother Company and it's President Jacques Bougie transfer to the new group in the same capacity. Pechney will account for 29 % and Algroup for 27 %.

- Prior to a merger, Algroup will separate the Lonza Works in Visp and turn it back into an individual Company. Lonza is presently valued at approx. sfr. 6 bil.

- Algroup's Managing Director is expected to act in the same capacity in the new Group as well as take up one of the 12 seats on the Board of Directors.
