### Annual Financial Report

Financially, we have had a very successful year. Our biggest increase has been in the advertising income, nearly \$900 up over the previous year. Placing more funds on term deposit about 18 months ago has increased our interest income, and even the increase in membership by six equates to an extra \$150. Or, to compare further, the net increase of 34 members over the past five years equates to a total of \$850 !!

Expenditure has also increased somewhat over the previous year. Magazine printing costs increased by approx. \$50 per issue, and three 16-page issues were produced - one more than last year. The other large expenditure item was the registration fee for our Delegate to the Swiss Abroad Conference.


Once again I want to thank the many businesses for supporting the Helvetia through both regular or occasional advertising. This has always been a major source of income for the Society, and helps in a big way to keep subscriptions at an affordable minimum level for the benefit of our members. So, once again, I encourage you all to support our advertisers whenever possible.

I am also very proud to report that over the past five years, since 1997, we have been able to increase the Swiss Society's asset base by the substantial sum of \$9905, so we are able to hand over a financially very stable and healthy organisation.
